Selection of Figure Skating Officials

During its meeting on October 17-18, 2104 the ISU Council approved the following Officials selection procedure:

- 1. All Officials must have at least the qualification for "ISU"
- 2. Required are
 - 3 Referees, one of which must be eligible for Ice Dance
 - 3 Technical Controllers, one of which must be eligible for Ice Dance
 - 6 Technical Specialists, two must be eligible for Ice Dance
 - 1 Data Operator
 - 1 Replay Operator
 - 28 Judges

All Officials except the Judges shall be appointed in line with Art. 16/2.f) of the ISU Constitution.

- 3. The composition of the panel of Judges will be made as follows:
 - 9 Judges with the Ice Dance qualification are selected to serve in the Ice Dance panel.
 - 9 Judges with the qualification for Single & Pairs are selected to serve in the Pair panel.
 - 5 Judges with the qualification for Single & Pairs are selected to serve in the Men/Ladies panel; 4 Judges from the Pair panel will be added to complete the panel of 9 Judges
 - 4 Judges with the qualification for Single & Pairs are selected to serve in the Men/Ladies panel; 5 Judges from the Pair panel will be added to complete the panel of 9 Judges

There will be a draw between "Men" and "Ladies", which panel will have 5 respective 4 Judges from the Pair panel.

- 4. Selection of Judges
 - 4.1 Members with an entry in the respective discipline and in the order of their qualification (World Junior Championships, followed by the Junior Grand Prix ranking), will have the right to enter with a Judge.
 - 4.2 According to the composition of the panels (see paragraph 3), the Members will be informed immediately after the conclusion of the Junior Grand Prix Series, about their Judge's quota.

- 4.3 If a Member is not able to send a Judge as to paragraph 2 above, the next qualified Member (order see paragraph 4.1) will be called and invited with a Judge.
- 4.4 If there are not enough Judges to compose a panel of 9 Judges, The ranking in the requested discipline in the Junior Grand Prix ranking order will be taken into consideration for selecting additional Judges.
- 4.5 For each discipline there is a need to draw one (1) substitute Judge, who will be on stand-by position. The draw principle for such substitute judges will follow the basic principle of qualification.

5. Timing

5.1 Immediately following the last qualifying event (Junior Grand Prix – Oct. 11th, 2015 (estimated), a list of qualified Judges will be established. On the occasion of the "Skate Canada" event, the VP will conduct the draw according to the procedure as laid out in paragraph 4.
