### What is REVEAL?

- REVEAL is a platform, developed by the International Testing Agency (ITA), that enables you to report anything suspicious you have seen, heard, or experienced about DOPING in a completely anonymous and secure manner.
- The ISU has integrated the REVEAL platform into the ISU's digital communication environment for confidential sharing of information.
- If you are wondering if your information is important enough, if you have doubts that your information is relevant, or if you are afraid of sharing it – please report it and be assured that your information will be treated in a strictly confidential and sensitive manner.

### Who can report on REVEAL?



- Everyone – skaters/athletes, support personnel, coaches, parents, event organisers, officials – can share information on any doping offence or suspicion through 'REVEAL'.
- All persons involved in sport have a responsibility to protect and promote Clean Sport.

### What can be reported?



- Any alleged Anti-Doping Rule Violation or any act or inaction that could undermine the fight against doping.
- A doping-related misconduct.
- Any detected, identified, and/or witnessed suspicious behaviour.
- Reasonable grounds for suspecting that cheating has occurred.

### Purpose of REVEAL



- REVEAL was designed to help uncover doping violations through the confidential sharing of information.
- The reporters can share any suspicions on the REVEAL platform in a completely confidential or even anonymous manner.
- REVEAL was developed in consultation with the athletes, taking into consideration their needs, concerns, and expectations of a modern information reporting platform.



## Benefits of REVEAL

- Information shared via REVEAL will be processed with the highest level of integrity and rigor by the ITA's Intelligence & Investigation department.
- The ITA's I&I experts will build thorough evidence-based cases in pursuit of prosecuting Anti-Doping Rule Violations.
- Athletes, Support Personnel, or members of the public can exchange information with ITA I&I through a secure mailbox.
- The ISU will coordinate and follow-up on the investigations with the ITA and take appropriate steps and actions for proper resolution.

## A REAL CASE by ITA

A recent REVEAL report identified an athlete with a performance increase of 20% in a short period, training at a location known for sale and use of performance-enhancing drugs.

ITA Intelligence and Investigations (I&I) department communicated with the reporter via a confidential inbox and identified specific days, times and locations to target-test the athlete.

ITA organized a No Advance Notice Out-of-Competition target test as per the reporting, and the test sample result came back positive.

The athlete was ultimately charged with an Anti-Doping Rule Violation and banned from future competitions.

The reporter's identity remained unknown to anyone except for the I&I officer.

## FAQ's

### 1. Where do I report a Doping misconduct?

### 2. I know of some fellow Skaters who indulge in doping misconduct through their coaches and team doctors, but I fear retaliation if I report them on REVEAL.

Any reporting on REVEAL is completely anonymous, any information you provide on the platform shall be treated in a confidential and sensible manner. Your name or the fact that it was you who complained will never be public, so rest assured, you can report any misconduct on the REVEAL platform without any fear of retaliation.
