The FEDERAZIONE ITALIANA SPORT DEL GHIACCIO announces that, in collaboration with CIRCOLO PATTINATORI ARTISTICI TRENTO, with the support of the ISU Development Program, it is organizing an International Synchronized Skating High Level Development Camp for Synchronized and Figure Skating Skaters, Coaches and Officials of Junior and Senior age and level, to be held in:

Trento, Italy, August 26-29, 2019

Location: PALAGHIACCIO DI TRENTO – Ice rink in Trento city, Italy and SAMBAPOLIS – University Sport Center of Trento.

The purpose of the camp is:

- The development of Synchronized Skating Skaters, Coaches and Officials to a higher technical level and the introduction of Synchronized Skating in new areas where it is not yet traditionally pursued, but where Figure Skating is already popular and there are resources to push the discipline.
- Enabling a long-term, high level development process for the Skaters and Teams in cooperation with their Coaches, with the aim to elevate the Teams to a higher level.
- Initiating a new development collaboration between Skaters, Coaches and Officials from the same country as from different countries, who could collaborate together in the future.
- Encouraging an open dialogue among different nations. Utilizing and increasing co-operation between various stakeholders.
- Support the general knowledge of the Officials, trying to put them in touch with the other side represented by the Coaches and the Skaters in order to facilitate the achievement of the same goal and a constructive exchange of knowledge.

Top, world-class Coaches and Officials will moderate the camp. Daily on-ice and off-ice classes will include theory and choreographic inputs. For a more personal learning effect, the experts will be available for one-to-one contact with participating Coaches.

The 1st edition of the Synchronized Skating High Level Development Camp 2019 is designed for Junior and Senior aged participants of a Team, SYS and Figure Skating Coaches and also SYS and Figure Skating Officials.

Accepted participants should arrange to arrive at Verona, Milan or Venice airport on August 25 by 14:00 (2pm) at the latest, in time for the prearranged transportation. For departure, the prearranged transportation from Trento to the respective airport will depart in the morning of August 30.

The opening of the Seminar will be on August 25 at 18:00 (6pm).

General

Entry and Participation criteria and conditions

The FEDERAZIONE ITALIANA SPORT DEL GHIACCIO invites the following 16 European continent ISU Member countries to send participants for the camp:

ISU Member Federations will select their representatives based on their own criteria of development of the discipline within the country.

- In order to provide adequate quality in the Camp, the organizing ISU Member will limit the capacity to a total of 80 participants.
- A waiting list will be created (in registration order) for those Skaters, Coaches or Officials
 which cannot be accepted in the first instance, in order to offer the opportunity for
 participation should cancellations occur. ISU Members are requested to be considerate with
 the timing of cancellations in order to give other participants the chance to be accepted.
- Each ISU Member may enter a 'Team' of 2 Skaters plus 2 Coaches to the seminar and 1 Official. In case of more than one request from a country, we will take into account the requests based on the capacity.
- We would like to accept one team per ISU Member but in case of less requests from some ISU Members we could also accept more Teams from the same country. We will also evaluate the possibility to open the seminar to more countries in the future
- Only legitimate Synchronized Team members and Coaches are to be entered. Skaters must be steady/confirmed members of the same Team who will be competing/skating during the upcoming season (2019/20). Coaches must be coaching the Team participating in the Camp.
- Figures Skating Skaters, Coaches and Officials, who will be interested to create a SYS team in the future may be entered.
- The Seminar is also open to Coaches wishing to attend without Skaters, at their own expenses.
- Additional Coaches above the quota may also attend at their own expense. Details will be provided to the individuals concerned upon application.







- Accepted participants must participate from the beginning to the end of the Camp unless they receive permission to do otherwise prior to acceptance.
- Skaters must participate together with their announced Coaches. Should an announced Coach unexpectedly be unable to attend, subject to receiving permission from the Organizing Committee, the participating Skaters must be accompanied by a responsible chaperone for the whole duration of the Camp.
- All participants must have Medical Insurance and have their valid Insurance Card with them to attend the seminar.

Expenses

The financial responsibility for the Camp is divided as follows:

- The living expenses (room and meals) for the accepted 2 Skaters, 2 Coaches and 1 Official
 per ISU Member will be borne by the OC for the period from dinner on Sunday, August 25,
 to breakfast on Friday, August 30, 2019;
- The travel expenses from the airports of Milano/Verona/Venezia to Trento and back for all accepted participating Coaches, Skaters and Officials will be borne by the OC;
- ISU Members will be responsible for travel expenses to the airports of Milano/Verona/Venezia and back for all participating Coaches, Skaters and Officials;
- ISU Members shall also be responsible for travel and living expenses for Coaches attending without participating Skaters, or who are outside of the quota;
- There will be a Symbolic Participation Fee of EURO 500 per accepted and participating Team (2 Skaters, 2 Coaches and 1 Official).
- <u>Cancellation policy</u>

All the facilities, including the Hotel, have to be booked and paid by the OC for the accepted participants one month in advance. Consequently, no cancellations can be accepted after the following deadline:

Cancellation deadline: Friday, July 26, 2019.

The OC shall invoice to the concerned ISU Members the related cancellation fees/costs representing 80% of the Hotel rate of the concerned person(s).

Applications

Applications must be received from the respective ISU Member in order to be considered. ISU Members are requested to clearly indicate their priority of acceptance when applying.
