# ANNOUNCEMENT

EGNA DANCE TROPHY 2023  
INTERNATIONAL ICE DANCE COMPETITION  
9 - 12 FEBRUARY EGNA/NEUMARKT, ITALY



## 1. GENERAL INFORMATION

The Egna Dance Trophy 2023 Ice Dance International Competition will be conducted in accordance with the ISU Constitution and General Regulations for Season 2022/23, the Special Regulations & Technical Rules Single & Pair Skating and Ice Dance for Season 2022/23, and the relevant ISU Communications. All Members of the ISU and Clubs being members of National Skating Federations associated with the ISU, are invited to take part in the competition. Couples taking part in the Senior and Junior category must be entered through their respective Member Federation. In case of "Club Entry" the Organizing Committee only accepts the entry for Senior and Junior category in case the official Entry Forms are stamped by the Member Federation. Furthermore, in case of "Club Entry" the returned Entry Forms must be officially signed and stamped by the Member Federation to be accepted by the OC. Participation in the Egna Dance Trophy is open to all Competitors who belong to an ISU Member, and qualify with regard to eligibility according to Rule 102, provided their ages fall within the limits specified in Rule 108, paragraph 3 c) and they meet the participation, citizenship and residency requirements in Rule 109, paragraphs 1 through 5 and ISU Communication 2030 or any update of this Communication. In accordance with Rule 109 of the ISU General Regulations and ISU Communication 2030 all Skaters who do not have the nationality of the Member by which they have been entered or who, although having such nationality, have in the past represented another Member, must produce an ISU Clearance Certificate. Passports of all Skaters, as well as the ISU Clearance Certificate, if applicable, must be presented for verification at the accreditation of the event. All participants accept that personal data are collected by the Organizing Committee (OC) and such data are stored and used by the OC, and when necessary, third parties, for the purposes only of, and to the extent necessary only in relation to facilitate their participation in the competition; personal data may include but will not be limited to full legal name as per national identity documents, address, date of birth, nationality, sex.

### ACCESS TO THE COMPETITION

**Accreditation and access to the competition will only be possible for athletes, coaches and one team leader for each Nation.**

## 2. COMPETITION VENUE

All practice and competition will take place at the WürthArena, the address Via Brennero, 7 39044 Egna/Neumarkt (Bz), Italy. This complex features an indoor ice rink, temperature controlled with ice surfaces 60m x 30m.

### 3. TECHNICAL INFORMATION

#### SENIOR

##### Rhythm Dance

In accordance with ISU Technical Rules Ice Dance 2022/23, Rule 709 and pertinent ISU communications, rhythms, required elements and guidelines are those listed in ISU Communications 2468 and subsequent updates.

Duration: 2 min., 50 sec., +/- 10 sec

##### Free Dance

In accordance with ISU Technical Rules Ice Dance 2021, Rule 710, the required elements to be skated are those listed in ISU Communication 2468 and subsequent updates.

Duration: 4 min. +/- 10 sec.

#### JUNIOR

##### Rhythm Dance

In accordance with ISU Technical Rules Ice Dance 2022/23, Rule 709, rhythms, required elements and guidelines are those listed in ISU Communications 2468 and subsequent updates.

Duration: 2 min., 50 sec., +/- 10 sec

##### Free Dance

In accordance with ISU Technical Rules Ice Dance 2022/23, Rule 710. The required elements to be skated are those listed in ISU Communications 2468 and subsequent updates.

Duration: 3 min., 30 sec., +/- 10 sec.

#### ADVANCED NOVICE

##### Pattern Dances

In accordance with ISU Technical Rules Ice Dance 2022/23, Rule 711.

Pattern required elements and guidelines are those listed in ISU Communications 2463 and subsequent updates.

Two (2) Pattern Dances are to be skated:

##### Westminster Waltz and Argentine Tango

Couples shall provide their own music for all Pattern Dances.

Free Dance duration: 3 min., +/- 10 sec

In accordance with ISU Technical Rules Ice Dance 2022/23, Rule 710. The required elements to be skated are those listed in ISU Communications 2468 and subsequent updates.

#### INTERMEDIATE NOVICE

##### Pattern Dances

In accordance with ISU Technical Rules Ice Dance 2022/23, Rule 711. Pattern required elements and guidelines are those listed in ISU Communications 2463 and subsequent updates.

One of the two groups, announced for the season, shall be drawn before the first practices of the competition. Each group contains two (2) Pattern Dances:

Group 1: Roker Foxtrot and American Waltz

Group 2: Fourteenstep and Tango

Couples shall provide their own music for all Pattern Dances.

Free Dance Duration: 2 min. 30 sec +/-10 sec

In accordance with ISU Technical Rules Ice Dance 2022/23, Rule 710. The required elements to be skated are those listed in ISU Communications 2463 and subsequent updates.

## **BASIC NOVICE**

Pattern Dances

In accordance with ISU Technical Rules Ice Dance 2022/23, Rule 711.

Pattern required elements and guidelines are those listed in ISU Communications 2463 and subsequent updates.

Two (2) Pattern Dances are to be skated:

Swing Dance, Willow Waltz and Tango Fiesta

Couples shall provide their own music for all Pattern Dances.

Free Dance duration: 2 min., +/- 10 sec

In accordance with ISU Technical Rules Ice Dance 2022/23, Rule 710. The required elements to be skated are those listed in ISU Communications 2463 and subsequent updates

## **4. ENTRIES**

ENTRIES OF COMPETITORS: Only ISU Members can enter competitors in each category. The OC reserves the right to limit the number of participants to one (1) entry per ISU Member in each category in case of overcrowding. With the Entry forms, the "Program Content Sheet" must also be returned to the Organizing Committee in due time (not later than 11 January 2022). It is mandatory that the Program Content Sheet must be filled in precisely by each couple in English using the terminology for the elements listed in the respective ISU Communication. It is not permitted to hand over the Program Content Sheets directly to the acting Officials.

ENTRIES OF JUDGES: Each participating ISU Member may nominate one judge and one substitute judge for the event in which the Member has Competitor(s) entered. Only ISU and international judges will be accepted. The OC reserves the right to limit the number of judges in accordance with the number of the couple's entries. The confirmation of the list of judges will be announced in due time.

DEADLINE FOR ENTRIES: **All entries must be done through the ISU Online Registration System (ORS) by January 11, 2023.** Declarations will need to be uploaded to the ORS as well.

**All entries sent after January 11, 2023 are declared to be late entry.** Entry Fees are requested to be paid no later than January 11, 2023, by bank transfer. Please note that all banking charges have to be on the sender. **Payment of the fee is necessary to confirm the entry.**

## 5. JUDGES, REFEREES AND TECHNICAL PANEL

For all the nominated judges the Organizer will provide accommodation and meals beginning with dinner on Thursday, February 9, 2023 through breakfast on Sunday, February 12, 2023.

Judges and officials taking part in the Competition are requested to announce the flight/train numbers, dates and times of arrival and departure or any other information concerning transportation to the Organizing Committee as soon as possible but no later than January 14, 2022, to organize check-ins and check-outs. Please note that the OC will not organize transfer for the judges, who have to arrange them with their federations.

## 6. REGISTRATION

Accreditation will be at the Ice Rink starting from **8 February 2023**. Please note, that payment by bank transfer has to be done prior to the arrival. All transfer charges are to be paid by the participant. All the Couples are requested to present a valid passport as per ISU rules at the time of registration. In accordance with the ISU Directive please note that at the time of registration (Entry fee, music, hotel arrangements) we have to copy and file the passport of the Skaters (in case you happen to bring it with you or send it by email beforehand it will help our work and make us very happy).

## 7. DRAW

Due to the current Covid situation, OC wants to avoid gatherings during the draw. For this reason, the starting order will be drawn by the Italian Federation FISG on **Wednesday 1st February at 17.30 at FISG Headquarters**. No draw after Rhythm Dance and Pattern Dance. Starting order for Free Dance will be according the reverse of the Rhythm Dance and Pattern Dance results.

## 8. MUSIC

**Music has to be sent in file .mp3 to music.egna@gmail.com**. All files must show the **competitor's name**, the nation and the exact running time of the music. Each program (Pattern Dance, Rhythm Dance, Free Dance) must be saved in a separate file and should be labelled with the name of the ISU Member, name of the category, segment and the names of the competitors.

## 9. REWARD

Awarding ceremonies will be just for the first three places in every category. Presents for all participants at the accreditation point. The exact time of the Awarding Ceremonies will be announced in the detailed schedule in due time.

## 10. SCHEDULE

Please, be informed that only the daily starting times are fixed. Following the morning start the time schedule of the event is flexible, which means that in case of cancellations certain categories may start some time earlier than in the Preliminary Schedule. Please, be informed that all changes in entries and Preliminary Program might be followed at [www.fisg.it](http://www.fisg.it) and [www.ygacademy.it](http://www.ygacademy.it) and on the information board in the ice rink.

## 11. TRANSPORTATION

Please, be aware that the Organizing Committee does not provide any transportation to the participants.

## 12. LIABILITY

The Organizer assumes no responsibility for or liability with respect to bodily or personal injury or property damage incurred in connection by Competitors and Officials. Furthermore, the OC is not responsible for any contagion that occurs at the event outside of compliance with the prevention protocols implemented.

In accordance with Rule 119, it is the sole responsibility of each Member participating in the 2023 Egna Dance Trophy to provide medical and accident insurance for their athletes, officials and all other members of the Member's team. Such insurance must assure full medical attendance and also the return to home country by air transport or by other expeditious means of the ill or injured person.

THE OFFICIAL AND FINAL SCHEDULE OF EVENTS WILL BE PUBLISHED AFTER THE REGISTRATION OF ALL ENTRIES. The organizer reserves the right to change the schedule of competition!
