O GENERAL REGULATIONS

The Essent ISU World Single Distances Speed Skating Championships will be held under the 2010 ISU General Regulations and Special Regulations/Technical Rules for Speed Skating and relevant ISU Communications.

O TITLES & PRIZES

The winners of the distances will bear the titles "World Speed Skating Champion __ meters for 2011" and "Lady World Speed Skating Champion __ meters for 2011", respectively. The winners of the Team Pursuit competitions will bear the titles "World Speed Skating Team Pursuit Champions for 2011" and "Ladies World Speed Skating Team Pursuit Champions for 2011". All winners will be awarded the ISU Championships Gold Medals. Competitors placed second and third will each be awarded the ISU Silver and Bronze Championships Medals respectively in accordance with ISU Rule 133 and 134. Prize money will be awarded according to ISU Communications No. 1509.

O THE TRACK

The Ice Hall Inzell is a fully enclosed speed skating facility with a standard speed skating track of 400 meters to the Iap. The width of each Iane is 4 meters with an inside training Iane of 4 meters. The radii of the inner and outer competition Ianes are 25 and 29 meters respectively.

O ENTRIES

Entries for ISU Championships can only be made through the respective ISU Members on the official ISU entry forms. Entries for the Essent ISU World Single Distances Speed Skating Championships will only be accepted for Skaters and pursuit teams who are qualified through results achieved in World Cup Speed Skating Competitions or in ISU Championships during the current season, according to qualification lists published by the ISU. Skaters in a reserve list position on the qualification lists may also be entered, but their participation in the Championships will depend on the total number of entries for the distance concerned and specific conditions mentioned in Rule 208, paragraph 2.

ISU Members may enter a maximum of 3 Competitors in each distance. If more than 3 skaters from the same Member are among the qualified Skaters, the final entries from that Member must indicate which of these Skaters shall participate in the Championship. Remaining qualified Skaters may be entered as substitutes for the distance concerned. The total number of Competitors on the distances will be limited as follows:

Preliminary entries of competitors and substitutes, if possible with names, must be received by Sunday February 20, 2011 by the Organizing Committee in accordance with ISU rule 208, paragraph 8.

Final entries must reach the Organizing Committee by letter, fax or electronic mail not later than Monday March 7, 2011 (see Rule 208, paragraph 8 & 9).

Please note that for all persons entered by the Members the procedures in regard to the Declaration for Competitors and Officials (all team Officials requiring an accreditation) entering ISU Events (Rule 131) as outlined in ISU Communication 1628 need to be strictly observed. For more details please refer to Rules 115, 131 and 208.

CITIZENSHIP/RESIDENCE REQUIREMENTS AND CLEARANCE PROCEDURES

In accordance with Rule 109 of the ISU Regulations and ISU Communications No. 1420, all skaters who do not have the nationality of the Member by which they have been entered or who, although having such nationality, have in the past represented another Member, must produce an ISU Clearance Certificate.

Anti Doping tests will be carried out in accordance with the valid ISU Anti-Doping Code (ISU Communications No. 1520, 1603 and 1604 or any further update of these Communications).

The Speed Skating track at the Ice Hall Inzell will be open for training for entered competitors from March 7, 2011. Trial Starts will be organized on Wednesday, March 9, 2011.
