REGULATIONS

The ISU World Junior Speed Skating Championships 2013 will be held in accordance with the 2012 Regulations of the International Skating Union (ISU) and relevant ISU Communications, in particular ISU Communication No. 1754. Participation in the ISU World Junior Speed Skating Championships is open to Junior Skaters who belong to an ISU Member (Rule 130, paragraph 1). A Junior is a Skater who has not reached the age of 19 by July 1, 2012 (Rule 108, paragraph 1b) and has achieved the required qualifying times according to ISU Communication No. 1754.

The Championships will include the following events:

Ladies, single distances: 500 meters (2 races), 1000 meters, 1500 meters, 3000 meters; Men, single distances: 500 meters (2 races), 1000 meters, 1500 meters, 5000 meters;

Ladies, allround combination: 500, 1500, 1000 and 3000 meters; Men, allround combination: 500, 3000, 1500 and 5000 meters;

Team Pursuit race for Ladies: 6 laps by national teams of 3 Skaters each; Team Pursuit race for Men: 8 laps by national teams of 3 Skaters each.

TRACK

A standard speed skating track of 400 meters to the lap laid out at Ice Rink Ritten / Arena Ritten, an artificially frozen outdoor skating rink in Ritten / Collalbo. The radii of the inner and outer competition lanes are 26 and 30 meters, respectively. The width of the inside training lane is 4 meters.

TITLE AND AWARDS

The winners of the allround combination are the Skaters with the lowest total of points after 4 distances have been completed (Rule 265, paragraph 2 and 268, paragraph 1). The winner will bear the title: "Lady World Junior Allround Speed Skating Champion for 2013" and "World Junior Allround Speed Skating Champion for 2013", respectively (Rule 133, paragraph e), and will each be awarded the ISU Championships gold medal. The Skaters placed second and third in the final classification after 4 distances will be awarded the ISU Championships silver and bronze medals, respectively. The winners of the distances will bear the titles "Lady World Junior Speed Skating Champion ____ meters for 2013" and "World Junior Speed Skating Championships gold medal. The Skaters placed second and third in the respective distance will be awarded the ISU Championships silver and bronze medals. The winning teams of the Team Pursuit event will bear the titles "Ladies World Junior Speed Skating Team Pursuit Champions for 2013" and "Men World Junior Speed Skating Team Pursuit Champions for 2013" (Rule 133, paragraph f). Prize money will be awarded according to ISU Communication No. 1509

ENTRIES

Entries must be made only through the respective ISU Members using the official ISU entry forms (Rule 131, paragraph 1) according to ISU Regulations and ISU Communication No. 1754. Each ISU Member may enter maximum 5 Ladies and 5 Men, and 1 substitute per category (Rule 208, paragraph 7). Only skaters who have achieved, during the seasons 2011/12 or 2012/13, the qualifying times listed in ISU Communication No. 1754 may be entered:

To be entered for Single Distance events a Skater must have achieved the qualifying time for the distance concerned. However, a Skater entered for the Allround event, is permitted to compete (and will be considered as automatically entered) in the respective Single Distance events, except for the 500 m. To be entered for the Allround Championships a Skater must have achieved the listed Allround qualifying time in 1500m (Ladies) and 3000m (Men).

To be entered for the Team Pursuit event, a Skater must have achieved at least one of the above mentioned qualifying times. Further details on the entry rules are given in ISU Communication No. 1754, paragraph 2.1 e.

<u>The Preliminary entry</u> with the number of Competitors & substitutes and the number of coaches and other team staff, as well as provisional names of the Competitors and team leader must be communicated to the Organizing Committee at the latest by February 4, 2013 (See Rule 208, paragraph 8).

<u>Final entries</u> including the names of the Competitors and available substitutes, as well as the names of the team leader, coaches and other team staff for whom an accreditation is required must reach the Organizing Committee by letter, fax or electronic mail at the latest by 12:00 noon (local time) on February 19, 2013 (see Rule 208, paragraph 9).

Please note that for all persons entered by the Members, the procedures regarding the Declaration for Competitors and Officials (all team officials requiring an accreditation) entering ISU Events (Rule 131) as outlined in ISU Communication No. 1628, need to be strictly observed.

For more details please refer to Rules 115, 131 and 208.

DRAWING

The drawings will be made in accordance with Rule 239 and 243.

ANTI-DOPING

Anti-doping tests will be carried out in accordance with the valid ISU Anti-Doping Code. (ISU Communications No. 1693, 1694, 1765 and 1766 or any further update of these Communications).

TRAINING TIMES

The speed skating track will be open for training for entered Competitors from Monday February 18, 2013. Trial starts will be organized on Thursday, February 21, 2013. Only accredited Competitors, substitutes and team officials will be allowed to enter the ice-rink during the official training hours.

CITIZENSHIP/RESIDENCE REQUIREMENTS & CLEARANCE PROCEDURE

In accordance with Rule 109 of the ISU Regulations and ISU Communication No. 1420, all Skaters who do not have the nationality of the Member by which they have been entered or who, although having such nationality, have in the past represented another Member, must produce an ISU Clearance Certificate.

LIABILITY

In accordance with Rule 119 of the ISU General Regulations, the ISU, Italian Ice Sport Federation and the Organizing Committee assume no responsibility for or liability with respect to bodily or personal injury or property loss or damage incurred in connection with these Championships. Each Member is solely responsible for providing insurance coverage thereto.

BOARD AND LODGING

The Organizing Committee will be responsible for expenses for board and lodging at the official hotel from lunch on Thursday, February 21, 2013 until lunch on Monday, February 25, 2013 (Rule 137 paragraphs 10 and 14) for entered Competitors (maximum 5 Ladies and 5 Men respectively) and 1 team leader or coach for each participating ISU Member. Expenses of other Skaters and team officials (i.e. entered substitutes, coaches, other team staff members or accompanying persons) other than those mentioned above, as well as expenses before or after the period mentioned above, will be at their own expense.
