General

General Regulations

The Southeast Asian (SEA) Trophy will be organised in accordance with the 2016 Regulations of the International Skating Union (ISU) and relevant ISU Communications, and the conditions included in this announcement. This international competition is sanctioned by the International Skating Union (ISU).

Participation

Participation in the Southeast Asian (SEA) Trophy is open to all ISU members of Southeast Asia. Entries must be made only through the respective members of the International Skating Union (ISU Rule 131).

Competition Format

The individual competition is an All Round competition. All Finals System and optional knock out system (elimination system) is used as the qualification procedure. The make-up of the races will be made in accordance with Rule 296 3 c), 4, 5 and 6. Final points (34, 21, 13, 8, 5, 3, 2, 1) will be awarded in the respective Final A considering Racing Rule 297 5 a) i).

Age is calculated as of July 1st preceding the competition. The organiser reserves the right to combine age groups and relay races.

Skaters can ONLY skate in ONE (1) category. Skaters will only be able to compete in the age category based on their birth date.

The programme is tentative and subject to change by the Organising Committee.

Competitors must be present in Singapore at the latest at 6pm on Friday, 6 January 2017 or the Organising Committee must receive documented proof that the competitors are in transit and will arrive in due time for the SEA Trophy. Competitors who do not comply with these requirements will be excluded.

A more detailed programme will be published in the week before the competition.

Track Conditions and Rink Dimensions

The Rink @ JCube is an artificially refrigerated indoor ice surface of 30 x 60 meters. Protective padding covers the boards in accordance with Rule 280, paragraph 5 and the respective ISU Communications. The tracks are in accordance with Rule 280, paragraphs 1 – 4.

Entries

Entries must be made electronically via <http://tinyurl.com/SEAForms2017>.

Individual Entries: Each ISU Member has the right to enter five (5) skaters per category per gender.

Relay Entries: Each ISU Member has the right to enter one (1) relay team per category per gender.

Deadline for Entries: 12 December 2016

Entry Fees (per entered skater regardless of number of races/distances joined)

Entry Fee: SGD100.00 by **12 December 2016**

Late Entry Fee: SGD150.00 by **27 December 2016**

**No entries will be accepted after 23:59, 27 December 2016 (GMT+8)
Any registration request beyond the second deadline will not be entertained.**

No refund for withdrawals for any reason. Entry fees must be paid electronically through the online registration portal by the entry deadline.

Helmet Covers & Transponders

Awards

Medals will be awarded to the first three competitors in the individual events and to each member of the winning relay teams.

Meals, Lodging, Travel and other Expenses

All expenses incurred by competitors of each participating ISU Member will be the responsibility of the individual.

Citizenship / Residency Requirement and Clearance Procedure

In accordance with Rule 109 of the ISU Regulations and the current ISU Communication, all skaters who do not have the nationality of the Member by which they have been entered, or who, although having such nationality, have in the past represented another Member, must produce an ISU Clearance Certificate.

Liability and Medical Insurance

In accordance with Rule 119 of the ISU General Regulations, the ISU, the Singapore Ice Skating Association and the Organising Committee assume no responsibility for or liability with respect to bodily or personal injury or property damage incurred in connection with the competition. Each Member is solely responsible for providing insurance (medical and accident) for their athletes.
