Judges Draw by number for ISU Figure Skating Championships 2022

Further to Rule 521 of the ISU Special Regulations and Technical Rules for Single & Pair Skating and Ice Dance the Special Regulations and Technical Rules for Synchronized Skating 2021, the draw for Judges by number for the above-mentioned Championships was held virtually on October 21, 2021, with the attendance of Mr. Alexander Lakernik, ISU Vice-President Figure Skating, Ms. Patricia Mayor, Sports Manager Figure Skating, Mr. Frédéric Laurent, Sports Coordinator Figure Skating, Ms. Cristel Garcia, Sports Coordinator Speed Skating and Mr. Grégoire Weber, auditor from BDO Ltd. Only a draw for the ISU World Figure Skating Championships 2022 and the ISU Four Continents Figure Skating Championships 2022 were made. All other results were kept as announced in Communication no. 2354, due to the cancellation of these Championships in the season 2020/21.

6. Draw of the panels

In accordance with Rule 521, paragraph 6. e)-g) and Rule 971, paragraph 5.d), the panels will be drawn on site 45 minutes before the start of each segment.

Note:

In accordance with Rule 521, paragraph 4 d) and 971, paragraph 3b), entries by names must be forwarded to the Organizing Committee of the Respective Championships to the ISU Secretariat, 21 days prior to the beginning of the Championships on the official entry form for Judges by name and/or by entering the Judges by name through the Figure Skating Online Registration System (ORS).

In accordance with Rules 521, paragraph 4 c), judges must not serve in more than one (1) discipline per ISU Championships.

In accordance with Rule 430, paragraph f), ISU Officials must not act as a Team Leader (or Assistant) in ISU Figure Skating (Single & Pair Skating/Ice Dance) Championships or Olympic Winter Games in the same season during which they serve as Referee, Judge, Technical Controller, Technical Specialist or OAC member in ISU Figure Skating (Single & Pair Skating /Ice Dance) Championships or Olympic Winter Games

In accordance with Rule 920, paragraph 1. f) (xi), ISU Officials must not act as a Team Leader (or Assistant) in ISU Synchronized Skating Championships in the same season during which they serve as Referee, Judge, Technical Controller, Technical Specialist or OAC member in ISU Synchronized Skating Championships.
