#### 7. Draw of the panels

In accordance with Rule 521, paragraph 6. e) -7. f) and Rule 971, paragraph 5.d), the panels will be drawn on site 45 minutes before the start of each segment.

#### Note:

In accordance with Rule 521, paragraph 4 d) and 971, paragraph 3b), entries by names must be forwarded to the Organizing Committee of the Respective Championships to the ISU Secretariat, 21 days prior to the beginning of the Championships on the official entry form for

Judges by name and/or by entering the Judges by name through the Figure Skating Online Registration System (ORS). According to Rule 521, paragraph 3, together with their entry, the ISU Members must indicate if their Judges are available to judge Pair Skating. In order to be eligible for Pair Skating, Judges who have never judged Pair Skating at any ISU Championships before, must have officiated satisfactorily in at least one International Competition and one ISU Event in Pair Skating during the forty-eight months preceding the ISU Championships.

In accordance with Rules 521, paragraph 4 c), Judges must not serve in more than one (1) discipline per ISU Championships.

In accordance with Rule 430, paragraph f), ISU Officials must not act as a Team Leader (or Assistant) in ISU Figure Skating (Single & Pair Skating/Ice Dance) Championships or Olympic Winter Games in the same season during which they serve as Referee, Judge, Technical Controller, Technical Specialist or OAC member in ISU Figure Skating (Single & Pair Skating /Ice Dance) Championships or Olympic Winter Games

In accordance with Rule 920, paragraph f) (xi), ISU Officials must not act as a Team Leader (or Assistant) in ISU Synchronized Skating Championships in the same season during which they serve as Referee, Judge, Technical Controller, Technical Specialist or OAC member in ISU Synchronized Skating Championships.
